EXECUTIVE SUMMARY

- 1. The MIGM opened the Grand Assembly in Ample Form with all the Line Officers present.
- 2. The Credentials Committee reported that there were eight Councils represented with twenty voting members present. During the meeting there were five non-voting Companions present.
- 3. MIPGM's Stephen J. Ponzillo III, Patrick A. Curtis, Ronald L. Aughenbaugh, and James B. Coker were in attendance.
- 4. The Proceedings for the October 29, 2016 Annual Grand Assembly and April 29, 2017 Special Grand Assembly to confer the TIM Degree were approved without comment.
- 5. The MIGM gave his report, and announced he would not seek a second term.
- 6. The Grand Recorder gave his report and the report on the Operating Account which were both accepted.
- 7. The Grand Treasurer reported on his labors to correct Morgan Stanley's management guidelines for the Grand Council. The interim balance (April 30, 2017) was \$182,211.22
- 8. A budget suggested by the Grand Recorder was reviewed and amended, and then accepted.
- 9. The CMMRF Committee reported collecting \$1,120 in its raffle. \$500 will be paid to the name selected, and the balance sent on to CMMRF.
- 10. All the Council Bylaws amendments received and sent to the Jurisprudence Committee were approved without adverse comment. Councils are to act upon these changes unless and until any defect or conflict is found with the Constitution of this Grand Council.
- 11. The Report on the Super Excellent Master Degree stated 59 Companions received the SEM Degree.
- 12. The TIM Degree Proceedings noted that four TIM-Elects received the TIM Degree on April 29, 2017; Gary Kennedy, Enoch; John Mitchell, Hiram; Patrick Spangler, Salem; Dirk Wiker, Harmony.
- 13. The Time & Place Committee's report was received. The Grand Council will defer the decision on Time & Place to the final decision by the Grand Commandery on May 30, 2017, when further details are supplied by the committee.
- 14. A final report was presented on the April 27, 2017 Festive Board.
- 15. The proposed Standing Resolution No. 17 adopted as amended, see page 2
- 16. Elections for the 2017 2018 Grand Council Officers was held, and the following were elected: Robert B. Lumbert, MIGM; Randall L. Watson, RIDGM; Randolph Disney, RIGPCW; Patrick A. Curtis MIPGM, RIG Treasurer; Vernon H. Huebschman, RIG Recorder.

5. Report of the Most Illustrious Grand Master MIGM John A. Rafine

142nd Semi-Annual Report of the Most Illustrious Grand Master May 16, 2017

Most Worshipful Grand Master Vourvoulas, Right Puissant Assistant Deputy General Grand Master McCollum, Most Illustrious Grand Masters, Most Illustrious Past Grand Masters, Thrice Illustrious Masters, and Companions, welcome to the 142nd Semi-Annual Grand Assembly of the Grand Council of Royal and Select Masters of Maryland.

There were several challenges to overcome at the beginning of my term. A new Recorder and Treasurer were elected, and the transition still has not been completed. Our Grand Treasurer, Most Illustrious Past Grand Master Curtis, experienced considerable difficulty obtaining the delivery of our monthly account statements. Our Grand Recorder, Right Illustrious Vernon Huebschman, has been dealing with some health issues, and was contemplating resigning from office. Thankfully, his doctors have successfully been able to relieve the chronic pain he was experiencing, and although still mending, his health has improved to the point that he feels he will be able to continue his duties as Grand Recorder.

Companion Jeff Ament, informed me that he was unable to continue to serve as Grand Lecturer. We will miss his services. Most Illustrious Past Grand Master Gordon Davids volunteered to conduct the law school this year, and we appreciate his continued devotion to the Grand Council and Maryland Masonry.

In-State Activity

Palestine # 16 will be visited on June 5, and Carroll # 7 in September. York # 23 and Samuel Clemmons # 25 have not scheduled their Grand Visitation.

On May 9th, MIPGM James Coker, RIGR Vernon Huebschman, IGSent Kris Brown, and myself had the honor of installing the officers of Jerusalem Council #2. We have been asked to install the officers of Enoch Council # 10, King Solomon Council # 13 and Hiram Council # 5 and are looking forward to these events.

I have been pleased with the number of Council members present; however, the numbers of Grand Council officers attending has been less than desirable. We need our officers to honor their Grand Council commitments, and I have been less than successful accomplishing that.

Around the state, many Councils are performing their own degree work, with minimal, if any assistance from other Councils. Fantastic! Some Councils are taking in substantial numbers of candidates. Unfortunately, they are not returning to their Council. I have discussed some ideas with their Thrice Illustrious Master, and plans are underway to increase the number attending regular meetings.

The conferral of the Super Excellent Master Degree at the Scottish Rite Temple was a very rewarding experience. Sixty-Six Companions received this degree and seven new companions received their Royal and Select Master degrees that morning. Again, thanks to Right Illustrious Grand Principal Conductor of the Work, Companion Randall Watson, for managing this event.



The Grand Council Festive Board held on April 27th was very successful. This event sold out within two weeks after ticket sales started. It was a lot of work and a lot of fun! Thanks to John Mitchell for his hard work with this event, Hiram Council #5 for hosting the event, and to all Companions attending this event. Dr. S. Brent Morris gave a most –informative talk about the High Degrees of Masonry, and all attending had a fantastic time.

The Degree of Thrice Illustrious Master was conferred upon four Companions on Saturday, April 9, 2017. Congratulations to Companions Gary Kennedy (Enoch # 10), John Mitchell (Hiram # 5), Patrick Spangler (Salem # 11), and Dirk Wiker (Harmony # 20). All four Companions were certified proficient in the Royal and Select Master degrees, and opening and closing a Council. Would those four please stand for recognition.

Out-of-State Activity

To date, I have attended Grand Council Assemblies in Delaware, Washington, D.C., New Jersey, and Pennsylvania. Health issues have restricted me from air transportation and prolonged travel by auto. I plan to attend additional States if able. Regrets have been sent to each State I could not personally attend, and Right Illustrious Grand Master Robert Lumbert represented me at Rhode Island.

All states share the same concerns - lack of attendance, membership, lack of communication and increased costs among others. All states are addressing these concerns, and the comradery that exists in the North East enables the opportunity to discuss common concerns and possible solutions.

Website

The information superhighway has potholes and needs repair. We have not been successful with keeping our website updated. Changes are not being made timely, if at all, and is causing the delayed or non-receipt of information. A committee is being formed to resolve this problem. Our current webmaster, Companion Arthur Hebbeler, is experiencing health challenges, and informed us that he is resigning as webmaster. Eric Giesbrecht, a relative of Pat Curtis has agreed to serve as webmaster for the Grand Chapter and Grand Council websites, and we appreciate his assistance. We will get Eric started on this activity immediately. The webmaster cannot post changes to the website if he does not know about them, so all Councils need to provide the Grand Council with information for posting to our website.

Status of Initiatives

Further discussions with the newly-elected Right Puissant Grand Master of PA have renewed my hopes of restarting our tradition of meeting with the Grand Council of PA and holding a joint conferral of the Council degrees. While this will not happen until later this year, both PA and MD are interested in restarting this annual event.

Work has started on the Louis F. Bandell, Jr. Ritual Award I proposed. A draft of the plan has been submitted to me. I learned that there is another award, a monetary award that was left by his estate, and is not to be confused with this award.



Charitable Contributions

The Cryptic Masons Medical Research Foundation continues to be our primary charity. I was privileged to award three plaques to Concordia Council #1, Jerusalem Council, #2 and Carroll Council #7. Companion Lou Romeo works zealously to raise funds for CMMRF, and Maryland is in the middle of the State rankings this year. A raffle was created to raise money for the foundation, and we are going to draw the winning ticket at this time.

The Grand Council was invited to attend the fourth annual open Masonic Meeting at Charlotte Hall Veterans Home. Money is being raised to improve the outside garden area, install a shade structure, provide wheelchair-friendly picnic tables, rubber surfacing on the grounds area, and a canopy swing.

Although I did not personally attend, the Grand Council donated \$100 towards this most-worthy project.

Awards

The Grand Council is lacking a list of award recipients, and minutes of our assemblies are difficult to obtain. As such, we are not able to easily identify the pool of Companions eligible for awards. I would like any Council having a worthy candidate for a Council award notify me ASAP and provide me with a narrative containing the basis for making your nomination. I will work with the awards committee and Grand Recorder to get these awards processed timely so they can be presented at the Annual Assembly.

Term of Office

Unfortunately, personal health concerns along with mobility issues persist and are limiting my ability to perform the physical demands of my position. Rather than negatively affect the Grand Council, I have made the difficult decision to only complete one year as Most Illustrious Grand Master.

6 Report of the Grand Recorder

RI Comp. Vernon H. Huebschman

MIGM,

Transition

Thank you for your patience during my return to the Southeast Corner. While being a Masonic secretary has a lot of generic similarities, it is taking a while to become accustomed to the particulars of the Grand Council again.



Operating Account: M&T Bank

The MIGM and I visited the Dundalk Branch of M&T Bank to put the signature authority into his hands and mine. We also re-established contact with the M&T website which provides instant access to the disposition of deposits, checks written, and the bank statements going back to the establishment of the Operating Fund Account.

To facilitate the management of the Operating Account, which is the only account which can pay the financial obligations of the Grand Council, the MIGM has modified the signature authority practiced by the Grand Council Officers. The Grand Recorder may issue check checks up to and including \$500.00 under his single signature. Checks greater than \$500.00 require two signatures.

The entire statement history of the M&T Operating Account has been entered into QUICKEN which is a well-known account management program. The records of 2016 and 2017 to date have been reconciled using Quicken, providing definitive proof of accuracy of calculations, and a tool for the analysis of spending by the accounts established in the approved Annual Budget.

Please see the attached exhibits for the specifics of the 2015 – 2016 Annual Operating Report and the Interim 2016 – to date Operating Report.

General Grand Council

MIPGM Richard Naegele submitted the 2016 Annual Report to the General Grand Chapter, per the data supplied in the 2016 Annual Council Reports submitted and reported to the 2016 Annual Grand Council Assembly. There has been no communications received from their offices during my tenure.

IRS

The Grand Council has successfully submitted the IRS 990n Form for 2017. All Councils are reminded that the Recorder must file this report annually by computer to the IRS. The report requires the name and contact information of the presiding officer and the Recorder. There is a required affirmation that the Council has not received more than \$50,000 in revenue in the past year, and is still in operation. The Recorder must print a confirmation copy of the filing, which will later be attached to Annual Council Report. This procedure mirrors that adopted in Grand Chapter in 2016, and was 100% successful.

Council Locations

Two Councils have been forced to change the location of their Regular Assemblies. King Solomon Council No. 13 was displaced from Rockville the unilateral action of the host Lodge, and is presently operating in Perseverance Lodge in Germantown by dispensation of the MIGM until action taken by this Semi-Annual Grand Assembly. Similarly, Palestine Council No. 16 was displaced by the sales of the Masonic Temple in Hagerstown and is operating under the dispensation of the MIGM until a permanent location can be found.



Annual Reports

Council Recorders will note that the 2017 Annual Reports will be made to closely parallel the 2017 Chapter Reports, which should be useful for those Recorders who do double-duty on the Chapter side.

I respectfully request that Councils (and Chapters) complete their annual reports over the Summer months and get them to me as early as possible. The closing date of the annual report is officially August 31st, and are due to the Grand Recorder not later than October 1st. With the joining of the roles of Grand Secretary in Grand Chapter with that of Grand Recorder in Grand Council, that means that the 19 Chapter reports and the 15 Councils reports hit at the same time...assuming everyone adheres to the stated schedule. Thirty-Four annual report as impossible to review, correct as needed, and post into the now unified Grand Chapter Grand Council Database. The next task is to use this data to produce Dues Card for the same 34 bodies by their respective annual meetings. This work is combined with the general preparations for two annual meetings by the same person serving two grand presiding officers.

To relieve this situation, I ask that the secretaries and recorder complete their annual reports as soon as possible after their last spring meeting so that all new Companions will be entered on the report with their contact information (including Grand Lodge Membership Numbers), along with all deaths, NPD's and demits know to that time. We can always pick up summer deaths in the next annual report. I cannot produce your Council's dues cards until the information on membership status is in the database. Please consider cooperating with this request.

Grand Council Liability Insurance

The Grand Council devised a formula to spread the responsibility as equitably as possible among the 15 Councils and the Grand Council. The Grand Council pays a larger portion of total premium, while each Council pays on a per capita basis. MIPGM Naegele sent a mailing to each Council invoicing it for its per capita participation. All Councils have made their contributions at this time. The Premium was increased because of the relocation of King Solomon Council No. 13 based on different site conditions. The Grand Council paid this adjustment for 2017 only. The 2018 premium will be partitioned as was the 2017 premium.

MIGM, thank you for cooperation in helping me transition back these duties and your consideration of my recent health issues. While I was original not inclined to continue trying to serve both the Grand Chapter and the Grand Council as their administrative secretary, I am willing to give this situation the balance of this York Rite year, and will commit to serving in 2018 if the Companions would like me to continue. If however there is another Companion who the Grand Council would care to elect, I will support him and help in yet another transition.

I want to thank the members of this body for electing me to serve as their Grand Treasurer. The first half (October 2016 – April 2017) of this term has been an enlightening experience for me. I am still working on learning all the ins and outs of how to read the monthly statements provided by Morgan Stanley to me and the Grand Recorder.

Companions, we are apparently recovering quite well from the events of two years ago when our stocks were suffering from the economic conditions prevalent at that time. I am pleased to report that our well-diversified investments (Cash, Stocks, Bonds, and Mutual Funds) have recovered quite well, resulting in a significant increase this reporting period. With the wise investments made by those who served before me, I am able to report, during the past six months, our total investments at Morgan Stanley have grown by Ten Thousand, One Hundred and Eighty-nine dollars and eighty-three cents (\$10,089.83), giving us a total of One Hundred Eighty-two Thousand, Two Hundred and Eleven Dollars and Twenty-two cents (\$182,211.22).

The Grand Recorder has requested a withdrawal of Eight Thousand (\$8,000.00) to be transferred into the Operating Fund. Having sufficient funds in the account at Morgan Stanley, I concur with his request.

Although I am new to the position of Grand Treasurer for the Grand Council of Royal and Select Masters of Maryland, I am willing to serve another year should the Companions see fit to elect me for another term.

"Resolved:

That a constituent Maryland Council may assemble on the occasion of a Stated Assembly with five or more Companions of that Council, and with that as a sufficient number, conduct any normal business relevant to that Council.

If dispensation is granted by the Most Illustrious Grand Master which includes language to permit conduct of business at a Special Assembly, a Council may also conduct its normal business at a Special Assembly, as above, provided due notice is provided for the Special Assembly.

Normal business shall include election of candidates, reading and approving minutes, reception and payment of bills." Passed Unanimously.

Samuel Clemens Council has provided notice that they are working with Palestine Lodge to move to their facilities, and ask your dispensation to pursue this action and endure until the Annual Grand Assembly when a proposed amendment to their own bylaws will be offered for consideration.
