

Robert Lumbert was born in Cambridge, Massachusetts in 1949. He lived in the Boston area until graduation from high school. He received a Bachelor's degree from Dartmouth and a Master's degree from Cornell, both in mathematics. He moved to Maryland to take a job as a mathematician with the Department of Defense, a position he retired from in 2011.

His Masonic career began when he joined Battle Green Chapter, Order of DeMolay. After moving to Maryland, he became an advisor in what was then Glen Burnie Chapter. He currently serves on the State Staff as Awards Advisor. He has been awarded the Degree of Chevalier and is an active member of the Legion of Honor.

He was raised a Master Mason in Glen Burnie Lodge #213 in 1984 and served as Worshipful Master in 1991. He is currently the Secretary of the

Board of Grand Inspectors and the Grand Inspector for Ionic Lodge #145. He is also a member of Daylight Lodge #1.

He became a member of Concordia Chapter #1, RAM in 1987 as part of the Bicentennial Class. He served as High Priest in 1999-2001 and several times since. He was the Most Excellent Grand High Priest of the Grand Chapter of Maryland in 2010-12 and the Ambassador to Maryland from General Grand Chapter in 2014-17. He is currently the Excellent Master of Ceremonies in Maryland's Council of Anointed High Priests. He has received the Award for Meritorious Service in Bronze, the General Grand Chapter Ritual Award and the Ephraim Kirby award. He is also a member of Adonairam RAC #21 and an honorary member of Druid RAC #28.

He is a member of Concordia Council #1, serving as Thrice Illustrious Master in 2001-2 and is currently the Recorder. He was Most Illustrious Grand Master of the Grand Council of Maryland in 2017-19. He is currently the Senior Warden for the TIM degree.

144rd Annual Assembly Report of the Most Illustrious Grand Master

Report of the Most Illustrious Grand Master October 26, 2019

Most Worshipful Grand Master, Right Puissant General Grand Principal Conductor of the Work, Right Puissant Deputy General Grand Master, and my Companions all,

For the fourth and final time I am reporting to you as your Most Illustrious Grand Master. I thank you for being given the privilege of serving in this office, and I hope my efforts on your behalf have been satisfying to you. I judge the Grand Council to be in about the same shape as it was when I was installed two years ago. It is true we have lost one Council and are about to lose another. But I don't feel that these losses have weakened the Grand Council. Both Councils were struggling, and had one of my predecessors been of a more dictatorial bent, they

would have been closed long ago. Even now there are other Councils that are barely surviving and could reasonably be closed by fiat. But my feeling is that as long as the Companions wish to continue as a Council, they should be allowed to do so, if possible. Sometime in the future they may be able to revitalize themselves. That has happened before in this Jurisdiction.

Normally we have a memorial service as after the introduction of our distinguished guests. Since that didn't happen this year, I will pause at this time to remember our departed Companions with a moment of silence. As most of you know we lost Most Illustrious Past Grand Master Royce Watson in January, and we remembered him at the semi-annual in May. I ask you know to stand for a moment of silence in memory of him and the other 72 Companions who advanced to the Celestial Lodge above in the past year.

What I want to spend most of my time on today is looking ahead. If this Grand Council, and indeed York Rite Masonry in this state, is to prosper in the future, some rethinking needs to be done. What I am about to say may make some people unhappy. I do not mean to offend anyone. Think of what I say as "whispering good counsel in the ear of a Brother". If you do not think that what I am about to talk about applies to you, all well and good. If you do think it applies to you, please think about how you can make changes. If you're not sure, maybe some thinking is still in order. I am not going to criticize anyone in particular. But I think the fact that we are installing new leaders in all three Bodies gives us all a new start, and we can get away from "we didn't do it that way before". The first thing I'm going to talk about is communication, mainly communication between Grand Council leadership and the members. When someone is installed into a position like mine, he will often make some comment about just being the leader temporarily, and that it is the work of the entire body that makes things work. I wish I could make you all believe that. When I was Grand High Priest I sent out an e-mail roughly monthly keeping everyone apprised of goings-on in the Grand Chapter. It seemed to be well received. I intended to do the same as Grand Master. But when I asked for e-mail addresses to update my mailing list, I got exactly two responses. When I asked for suggestions for social events that the Grand Council might put on, I got just one response. When I offered to come for a Grand Visitation this year, only one Council asked me to come. Unfortunately, I was not able to come on the first date they suggested, and somehow the reschedule didn't take place. When I asked for the names of people who might be worthy of receiving one of the Grand Council awards, it seems that there aren't any. (Fortunately the Grand Council awards committee was able to give me some names). Companions, do you really believe that there is no one in your Council is doing good work and deserves to be recognized for it? I realize that I share some of the responsibility for this situation. I am not a very social person, so I don't get out and talk to a lot of people as many of you do. I am not married, so I don't have a good feel for what activities might appeal to the ladies. And I am the exact opposite of a micromanager. When I ask someone

to do something, I expect it will be done without harassment from me. If the task needs to be done, I will at least remind the person about it. But if it is something more optional, like making award nominations, my feeling is that if you don't care, I can't make you. I understand the attraction of procrastination, being subject to it myself. But I do manage to get things done on time. If you are asked to make some suggestions in some area, try to do so. Even if they are not practical, they may suggest something to another person which can be done. And don't feel that if you suggest a project, you will be stuck doing it. If you have a position of responsibility, whether in Grand Council, a local Council, or any other organization, and you have a job to do, please get it done on time. Annual Reports were due to the Grand Recorder on September 30. As of that date, half the Councils had not turned them in. This is unacceptable. Our Grand Recorder has enough to do without having to contact local Recorders to find out where their report is. The majority of the report can be filled out on May 31, after your Installation. The only changes after that are deaths and perhaps NPD suspensions which occur up to August 31. This is not a hard task, but too many Recorders are not doing it. Perhaps Grand Council needs to consider some monetary penalty on late reports.

My second topic is York Rite Unity. We are fortunate in Maryland that the Grand Chapter, Grand Council and Grand Commandery get along and work together well. This is not necessarily the case in other jurisdictions. But there are things that we should be doing together but are not. The best example of this is the arrangements for Grand Sessions. Each Presiding Officer appoints his own Sessions Committee and his own Time and Place Committee. But there is little coordination among the three Bodies, and often members serve only for a year or two. This year I understand that when one Companion went to talk to a hotel about our 2020 Sessions, he was told that someone else had already been there. This is at the very least a waste of someone's time, and it could have repercussions if two different people enter into negotiations and have different requirements. I have been advocating the establishment of a joint committee, responsible for all aspects of organizing Grand Sessions. It would have nine members, and three would rotate off each year. This would provide continuity, while limiting any one person's commitment and allowing new blood to get involved. Unfortunately, this suggestion has been ignored. It may be that some Constitutional changes are needed to establish this, but that should be easy to accomplish.

Another thing I feel needs to be done is an update of our York Rite directory. The directory produced in 2010 is very much out of date. With the information available on our web site, the new version would only need to be a listing of the addresses, phone numbers and e-mails of certain of our Companions. While it would have to be updated from time to time, an annual addendum could be produced yearly, with a full revision done say every five years. This is something we really need, but no one else seems interested.

A third thing that needs work is allowing our Bodies, both local and state, to offer on-line payments. And working on it together makes the most sense. I tried to get some interest in this two years ago. I don't have knowledge about such matters. But I'm sure someone out there does. Please step forward. I wouldn't think it would take a lot of your time to get this started.

These items are clearly ones that all three Bodies need to be involved in. Other events would work perfectly well under the sponsorship of one Body. The Grand Chapter held a bowling tournament this year. It was successful, and I believe it will continue. It is a Grand Chapter event, and it should continue that way. On the other hand, Grand Council sponsored a Festive Board in 2017 and 2018. Because it involved a cost to the Grand Council, it made sense to invite the involvement of Grand Chapter and Grand Commandery. With more money to spend, it was hoped we could make it a bigger event, with more Brothers attending. It didn't work out that way this year, but I still have hopes for the future.

I was pleased to hear the announcement that the Keystone newsletter will henceforth be a York Rite publication. This was a great idea on the part of Most Excellent Bill. It is something I would have liked to have produced if I had the necessary computer skills. But making it a York Rite newsletter is the right thing to do, in my opinion. This is a way to present a united front, especially to those Brothers who have not yet seen fit to join our ranks. I know there is confusion at times due to the different way that York Rite and Scottish Rite are set up. This will help reduce the confusion.

I suppose this report can't be considered as official unless I say something about membership. We all know it is a problem. At this point I am not going to be able to solve it. But we all need to do what we can to help alleviate it, by recruiting members for Lodge and Chapter, as well as Council.

Lest you think that all I am going to do is voice some frustrations, I assure you that there are many areas in which the Grand Council, and Maryland York Rite Masonry in general, are doing a very good job. I have spoken a number of times about how well our ritual is done. In so many Jurisdictions doing ritual is more a job for the state officers, not the local ones. While we may do some courtesy work, many of our Councils can confer the degrees without help. Our state finances are in good shape. We stay within our budget for the most part, and we watch our expenses. In many Jurisdictions, one of the questions at Grand Sessions is always "how much are we going to increase the assessments?" And it is often at least \$1 or \$2 every year. We have not had a per capita increase for a few years, except to compensate for what the National Bodies charge us, and to pay for insurance. I don't know how long that can last, but let us hope any increase is still a few years off.

I also think our website is very good, and I thank Dan Brewer and those assisting him for keeping it that way. He too needs your help to keep things up to date, and I hope you will give it to him. Since I do a lot of travelling, I depend on



the websites of other Jurisdictions for dates and costs. This is not always easy to find, especially in a timely manner. Sometimes I can't find it all, or what I do find is last year's information. Our information is normally posted about three months before the Sessions, available to our members as well as those from out of state. Let me now mention a few subjects for future action. The first is education. I think you are all familiar with the Grand Lodge's education program. It is unlikely we could create something that elaborate for Grand Council (or Grand Chapter or Grand Commandery), but we can and should work harder within our local Councils to educate our Companions. A few years ago the "Capitular Masonry Education Course" was published as a means to educate Chapter members. There is now a similar volume for Cryptic Masonry. These books are not very expensive, and I would urge each Chapter or Council to purchase one. Even devoting just one or two meetings a year to education will help your members and might even increase your attendance.

I have done a lot of travelling representing both Grand Council and Grand Chapter. But I can't seem to convince other Grand Officers of the importance of doing so. In the past year only once was I at an out of state Grand Sessions where that another Grand Council officer attended and only once where a Grand Chapter officer attended. I'm not sure what the situation was with Grand Commandery, because their meetings don't always align with Chapter and Council meetings. Getting to know the people leading our sister Jurisdictions, hearing their problems and solutions, and sharing ours should be an important part of the job. I understand that jobs make travel difficult for some, but the Delaware Sessions, for example, are only about an hour's drive from Grand Lodge, and they do both Chapter and Council on the same Saturday. We are still waiting to hear if General Grand Council and General Grand Chapter will be creating a "mid-Atlantic" region at the Triennium next year. If they do, it will mean that there will be a York Rite Regional Conference much closer to us. In recent years these sessions have become very interesting and useful. But they have usually been in Albany. Attendance is not restricted to Grand Officers. Anyone can attend, and I think almost anyone would benefit. This year I learned that in Indiana they did a festival in which they conferred all the York Rite degrees, from Lodge to Commandery, in chronological order. There are a lot of connections among the degrees that we don't notice when they are conferred in the official order. I would have loved to have been at that festival. I don't know if we could do it in Maryland. Conferring all the degrees would be difficult, but exemplifying them, so that things could be shortened by say, leaving out the lectures, might be feasible. If you think about this some, you will realize that putting things in chronological order is not a simple task, and that some of the degrees would have to be broken into parts. In Indiana they also made some modifications to tie degrees together. For example, in the Royal Master degree, during the Soliloquy, the candidate sees someone lurking in the shadows. Then as he is going out the door, he hears "Ah Grand Master Hiram Abif, I am pleased to



meet you thus alone", and the door is shut.

I would like to call your attention to some awards available from General Grand Council. They haven't seemed to have gotten enough publicity in Maryland. First is the Lady of the Council award. This can be requested by any Companion, for the special lady in his life or to a lady who has been supportive of his Council in some way. This can be presented at some special event that your Council holds or at some bigger event like the Grand Sessions banquet. I know most of you know someone who is deserving of this award. Its cost is \$125. Also available from General Grand are a Veteran's Medal and a First Responder's Award. The Veteran's Medal serves a similar purpose to the one available from General Grand Chapter, and is available at a cost of \$25. The First Responder's Award can be presented to any first responder, even if he or she is not a Mason. A Mason receives a medal, while a non-Mason receives a lapel pin. The respective costs are \$25 and \$15. This is something you can consider if you are involved in a community outreach program. All these awards can be ordered through your Council Recorder. But you can also order them directly through the General Grand Councils website (crypticmasons.org).

And if you're looking for something that's free, General Grand Council publishes a "weekly" newsletter, called the "Weekly Decryption". It doesn't actually come out every week, but they are doing their best. It has some interesting articles, even ones about Maryland occasionally. You can sign up for it on the General Grand Council website. And please let your new members know about it.

As I mentioned, this is my last report to you as Most Illustrious Grand Master. I am not going into retirement, but I do not anticipate taking on any major jobs in the future. I do have a number of Secretarial positions to occupy me, and I intend to be involved in ritual as long as I am able. One project I have set for myself is an examination of the Grand Council Constitution. If you read it, it is very out of date in many areas and needs some revision in others. My intention is to have something ready for the semi-annual, but I'm not going to guarantee that. As a first step, I have drawn up a list of areas I think need to be changed and how they should be changed. I have copies available for anyone who is interested, and I would welcome comments. Of course ultimately it is you who will decide how the Constitution should be changed, not me.

7. Report of the Grand Recorder

RI Comp. Vernon H. Huebschman

Most illustrious Grand Master Lumbert,

- 1. **Membership** The Summary Report which is provided on the reverse of the Agenda shows the data supplied by the Recorders of each of our constituent Councils. I will leave to others to tease out the nuances that hide in the data points.
- 2. **Mergers** The Summary Report deals with the mergers of Palestine Council No. in Hiram Council No. 5, We are indebted to those who worked on these transitions that they went as well as they did.
- 3. Recorders I would like to express my sincere thanks to the Council Recorders who labored for the good management of their respective Councils. One Companion in each Council bears the responsibility for Membership management, communications, billing, history, record keeping, and coordination with the Grand Council. The Recorder must understand the Constitution of the Grand Council and the Bylaws of his own Council. Each year he must adapt to the programs of a new Thrice Illustrious Master or buttress the efforts of a TIM who is serving multiple terms. Our Recorders have a partner on the opposite side of the room in the Treasurer. It is his duty to keep a spotless record of the transactions of the Council and be sure the honor of the Council is pristine. I don't know of a single man who is a Recorder or Treasurer by birth, and few who have the specific training in management to hold these positions. They accept election because they know the life of their beloved Council depends on having someone in the Southeast Corner of the Council Room. No Recorder is perfect. Each Companion has his own set of skills, and an allowance of time and energy to devote to this position. This means performance among our Councils varies. Each Recorder does what he can with his talent and time. Please be grateful for his service and assist where you can. The greatest help is to respond quickly to dues notices, and requests for information...give timely responses so issues can be expeditiously resolved. Respect your Recorder's time. I have often heard it said that being a Recorder is a thankless job. Well, it should not be so.
- 4. School for Secretaries, Recorders, and Treasurers The third such School is scheduled for February 15, 2020...the third Saturday in February. This date is selected to coordinate with the Grand Masters Conference of North America which causes a lull in the Grand Master's regional Meetings. Comp. Charles Matulewicz, the appointed Asst Grand Secretary, is tasked with organization this school for 2020. Requests for honing specific skills and practices will narrow the scope of some of the topics we have covered in the past. Please mark your calendars and cooperate with Companion Matulewicz in his first major effort.

- 5. **IRS 990 N Reports** Several of our Councils are recovering from the loss of their Not for Profit Status. This happens when a Recorder loses his focus on his obligations. This process costs \$600 and many hours of effort. These reports are due after March 31st each year. They take 15 minutes to do, and it is 100% done on the internet. Each Council must make sure their officers are seeing to this obligation because the cost of reinstatement is significant when seen as a cost per member. Any officer can do this report. Maintaining the Not for Profit status is necessary to have an Employer Identification Number or EIN. Without the EIN, banks and financial institutions will not do business or establish accounts to serve your Council.
- 6. Retirement It is still my intention to retire from the offices of Grand Secretary and Grand Recorder in October 2020. I have been sharing my experiences with the elected grand officers and the designated Assistant Grand Recorder. My main concern is the preservation of a unified York Rite Database. This body of facts provides an invaluable tool for the care of the memberships of our Companions. The GLMMS is a wonderful asset to assist in the maintenance of this information but I cannot see that the GLMMS has the capacity of doing the same things that the YR Database does at this point. The Grand Encampment's membership information provides me no comfort in data integrity and the sovereignty of each of the other two Grand Bodies. Somehow the YR Database must remain one unified body of information for Council and Council. As an example of its utility, the Grand Commandery has to back feed information concerning its past officers and current dais officers to make possible the cost savings in unified mailings for our annual and semi-annual grand meetings. I urge our leadership to take great care with this imperfect but priceless tool that Companion Gene Racz, Past Grand Recorder, built a quarter of a century ago from index cards and scraps of paper.

Thank you, MIGM Lumbert, for the honor of serving you a second time as you have presided in the Grand East. Thank you for your service and your guidance when issues were sticky. I wish you the very best in you future endeavors in the Halls of Freemasonry where others will be calling for your leadership.

Report of the Grand Chapter/Council Committee for the Proposed Hagerstown Mergers: Ithiel Royal Arch Chapter No. 27 with Druid Royal Arch Chapter No. 28 Palestine Council No. 16 R&SM with Hiram Council No. 5 R&SM

The untimely death of beloved Secretary/Recorder Terry Smith on August 25, 2018, left Comp. R. Joseph White (MEHP of Ithiel Chapter No. 27 and TIM of Palestine Council No. 16) as the only regularly active member of these two Hagerstown bodies. Comp. White had sought assistance from the membership (of about 38) and found little interest in supporting either body. He then made known his intention to seek a merger with Druid RAC No. 28 and Hiram Council No. 5 R&SM in Cockeysville, MD.

Agreeably to their respective Constitutions MEGHP Eppig and MIGM Lumbert appointed a Dual Committee to respond to the intended merger and supervise the details of transition. The Hagerstown Merger Committee consists of PGHP/MIPGM Stephen J. Ponzillo, III, PGHP/RIDGM Randall L. Watson, and MIPGM/RIG Treasurer John A. Rafine.

Notice was made to the membership and a Joint Convocation/Assembly of Ithiel Royal Arch Chapter No. 27 and Palestine Council No. 16 R&SM was held Monday, November 5, 2018 with the following attending: MEHP/TIM R. Joseph White; MEGHP William C. Eppig; REGK Bruce G. Colburn; MIGM Robert B. Lumbert, PGHP; RIDGM Randall L. Watson, PGHP; TIM/EK John P. Mitchell; PTIM/ES William C. Hare; and Grand Secretary/Grand Recorder Vernon H. Huebschman, PGHP.

After some discussion describing the intended action, a motion was made, seconded, and unanimously approved for a merger under the following terms:

- 1. Ithiel Chapter No. 27 desired to cease operation, and merge into Druid Chapter No. 28.
- 2. Palestine Council No. 16 desired to cease operation, and merge into Hiram Council No. 5.
- 3. Each body would surrender all its respective assets, property, and paraphernalia to the target body.
- 4. Each Hagerstown body was current on all its financial responsibilities and would continue to meet all its obligations until the merger is agreed upon by the target bodies.
- 5. A second opportunity for the Ithiel/Palestine members to consider this action would be available at the stated Convocation/Assembly on December 3, 2018, if a voting quorum was present. If no quorum was available at that meeting, the decision on the motion at the November 5, 2018 Convocation/Assembly would stand as their final decision.
- That Druid and Hiram would respectively accept and honor the dues remissions status (and Life Memberships) of current Hagerstown members as permanent, should the merger proposals be ratified.
- 7. Upon the approval to merge by Druid/Hiram, the operation of Ithiel and Palestine would be immediately suspended pending confirmation by the MEGHP & MIGM and the voice of their Grand Bodies.



- 8. Upon merger ratification, all Hagerstown members would be transferred into Druid Chapter and Hiram Council.
- 9. Dues paid by Hagerstown members to the Hagerstown Bodies before the vote to approve the merger by Druid and Hiram would be deemed as paid in their new bodies for 2019.
- 10. A window of six months would be open to allow Hagerstown members who wished to belong elsewhere to transfer to other Maryland Chapters and Councils; if those bodies will not accept the transfers without affiliation fees, such fees would be paid by the appropriate Hagerstown body for the transferring members.
- 11. The physical properties of the Hagerstown bodies were in long term storage, and would become available when Friendship Lodge secured its permanent home, and emptied the storage unit.

The proposed merger was announced to the members of Druid Royal Arch Chapter No. 28 and Hiram Council No. 5 R&SM and scheduled for a vote on February 28, 2019. Hiram Council opened at 7:00 pm on that date and approved the merger and terms as proposed by Palestine Council. Druid Chapter opened at 7:30 pm and approved the merger and terms as proposed by Ithiel Chapter. This was reported at the May 2019 Semi-Annual Grand Convocation and Grand Assembly.

The Grand Secretary / Grand Recorder has transferred the 38 Ithiel/Palestine members into Druid/Hiram. He has been informed that three of the Hagerstown members have approached Enoch RAC No. 23 (and Enoch Council No. 10 R&SM) in Frederick, and Salem RAC No. 18 (and Salem Council No. 11 R&SM in Cumberland) about seeking a more convenient Mother Chapter. If they are accepted, their transfers will be made to the new Chapter/Council.

The Hagerstown bodies' financial accounts will be closed and the funds will be transmitted to Druid/Hiram in the near future.

Companions and friends,

Thank you for your trust and the opportunity to serve you and this Grand Council for the upcoming term.

I'd like to start by commenting on something that many of you have heard before, but want to point it out to those who haven't previously attended a function where I have been installed as the presiding officer. On October 8, 1979, just a bit over 40 years ago, the night I was raised to the Sublime Degree of Master Mason in Nanticoke Lodge #172 over on the Eastern Shore, the Worshipful Master stated that it was the Lodge's custom to present a Masonic bible to their newly raised members. He told me that the bible on the altar was mine, and that I could take it after the meeting closed. He also informed me that since I had come through as a single candidate and not

part of a class, that they had used that bible on the altar at both of the previous meetings when I had been initiated as an Entered Apprentice and passed to the degree of Fellowcraft; and so, I had taken all three Obligations of Masonry on that bible. Since that time, I have used this bible to take the oath of office every time I have been installed as the presiding officer of a Masonic or Masonic-related body, starting with Grand Commander of the Maryland DeMolay Court of Chevaliers, and including Patron of my Eastern Star Chapter. This has a great deal of significance and meaning for me, and I just wanted to share it with the Companions and guests.

Moving beyond my personal focus, I'd like to share some of the things that the Companions can expect in the upcoming term.

<u>Ritual:</u> Companion John Thomas has agreed to come back on board as Grand Lecturer to head up a major project to revise the Ritual. We currently have the white and purple books, which have the same issuance, but different content. I'd like the update to be in similar format to that done by Grand Chapter

and Grand Lodge for the Past Masters' Associations – and to include room diagrams & detailed floor movements; as well as full instructions on how to give signs & grips; and other actions such as sitting & standing.

<u>Super Excellent Master conferral</u> will be at the Scottish Rite on Saturday, April 4th. We'll look into obtaining the SEM Yarmulkes like MIPGM Coker obtained, and have them available for sale. The schedule for the day will most likely include conferring the Royal Master and Select Master Degrees in the morning; break for lunch; and begin conferral of the SEM at 1:00 pm. We'll ask the 32 cast members who last conferred it in 2017 to see if they can reprise their roles, but we could use some additional help in both speaking and nonspeaking parts. There are seven scenes in the SEM, and only 11 cast members were in only one scene – the other 21 were in two or more scenes. Please contact me if you are interested in assisting with this impressive Degree.

<u>The Grand Visitation</u> schedule is in the Fall Magazine's Maryland Supplement. At the request of the Councils, Jeshua #8, Zabud #9, Giblim #12, & Adoniram #21 will have a joint visitation hosted in Denton along with the Eastern Shore Royal Arch Chapters (Chesapeake #17, Talbot #22, Hayward #29 & Edenton #36). At the magazine submission deadline in August, the date hadn't been set. It will be Tuesday, March 3rd in Denton.

<u>CMMRF</u>: Companion Louis Romeo has agreed to come back as CMMRF Chairman. This year's major fund raiser is a raffle – tickets are \$5 each, and there will be two \$100 prize drawings done at our Semi-Annual in May. We've made up envelopes for each of the Grand Officers with 20 raffle tickets to sell. Please make sure you see me after the meeting to get your envelope.

Flyers are out for the York Rite Cruise, which will be aboard the Carnival Pride out of the Port of Baltimore departing Sunday, August 30th for 7-Nights to the Eastern Caribbean. Not only are you able to get a cabin at our Group Rate that is lower than you can get from the cruise line outside of our group, but a part of each ticket price goes to the three York Rite charities: RARA, CMMRF and KTEF. How often can you have fun, save money and donate to charity all at the same time? The current version of the flyer doesn't mention that the Group Block is only valid through April 1, 2020.

Finally, I wish to express thanks to each of you for being here with us today, and for all your support and service for York Rite Masonry.
