4. Report of the Grand Secretary

M.E.G.H.P.,

Congratulations to you and the officers on a successful first half of the term. You and your officers have been very busy during the first half of the term, and It has been a pleasure working with you this year.

Annual Reports: The Annual Reports for 2023 will be due at the end of September. The next few months would be an excellent time to prepare for them. An updated Annual Report form will be generated depending on the outcome today. The form Is located on the Grand Secretary page on the website. It has a change that should be a big help for the secretaries. The tabulation page at the end will now do it for you. This should help take care of any math mistakes.

990N: A yellow banner on the gateway page of yorkritemaryland.org links to the most expeditious route to the I.R.S. 990N submission page. Though the I.R.S. requires this form to be completed every two years, The Grand Chapter needs them completed every year. Yearly filing helps prevent a failure to report, primarily if a change in secretaries occurs. If this happens, you may lose your tax status and E.I.N. #.

The School for Secretaries, Recorders, and Treasurers: The 2023 school took place on March 18, 2023. We had 20+ in attendance. I want to thank all those who attended. We had to change the date from February due to conflicts. The new date had its problems, but we could hold the school, and I hope the information was helpful for those in attendance. Big Thank you to John Rafine for his assistance and his informative presentations.

Lifetime Achievement: The Lifetime Achievement Award is an honor presented by the Grand Chapter to members who have distinguished themselves by continuous and meritorious service to their respective Chapters, the Grand Chapter, Masonry in general, or the Community. The regalia was originally to be a Sash worn across the body but has seemed to be gone by the wayside, and a certificate seems to be the only recognition given.

Comp. Vern and I discussed replacing the sash and presenting something more substantial than a certificate. We devised a Breast Star to be worn on a jacket's right or left breast. I submitted the design and cost to the Awards committee to evaluate and propose a vote. I would recommend this change.

Membership Management System: I have received numerous inquiries from our secretaries concerning our membership Management system or lack thereof. I have looked into a few, and Grandview offers the most options and is geared to the masonic bodies. Cost is still a concern, and I would recommend a committee be appointed for a feasibility review.

Ritual Books: We have 25 white ritual books left and will need more shortly. A few meetings ago, the Grand Lecture, with a committee, was to review the book and make necessary corrections and additions. Not sure of the status, but once this is done, we can send it to a printer.

Service Pins: 25 and 50-year Service pins have been given to many deserving Royal Arch members over the last two years. I thank P.G.H.P. Robert Chase for ownership of this program. He has worked extremely hard to locate and present these pins, which the recipients greatly appreciate. We ask the chapters to continue to assist him in this endeavor.

5. Report of the Grand Treasurer

The report of the Grand Treasurer is that the Grand Chapter is in good financial condition. The Treasurers Final Report for 2022 is attached. Although the report shows the year being short \$4,951 in income, we spent \$5,857 less than budgeted and stayed in the black.

The Semi-Annual Treasurers Report for 2023, as of May 3, 2023, is attached, along with the 2023 Interim Report for the Trustees Reserve Fund. The Reserve Fund report shows the status of the account as of March 31, 2023.

The value of the account and its investments as of that date was \$505,503.70, that's a 7% increase since November 1st. The geo-political environment and world events have caused a lot of market volatility, but nothing changed in the fundamentals of these companies, the market has and will stabilize. The best advice for long-term investing is still to stay the course.

Also attached as reviewed by the Accounts and Finance committee is the proposed budget for 2024.
